
HEARING OFFICER ORDER

On April 6, 2009, all parties participated in a telephonic status conference with the hearing officer. The respondent's attorneys represented that they are having discussions with their client on how to proceed. The respondent's also represented that based on petitioners' recently filed motion to amend the petition and the amended petition, it intends to file a motion to withdraw its Demand for a Bill of Particulars in the next several days.

It was represented by the parties that discovery is proceeding and a written proposed discovery schedule will be submitted soon. The petitioner represented that it will file an additional waiver of the statutory decision deadline to and including October 1, 2009. To that end, the hearing will be held in early to mid July, 2009.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 14, 2009, at 11:00 a.m. The telephonic conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


