- 2. As part of my duties, I am responsible for the preparation of Administrative Citations issued by the Illinois EPA and the negotiation and litigation of appeals filed pursuant to such Administrative Citations. As part of my job experience, I have also submitted travel vouchers for reimbursement.
- 3. I have reviewed the Illinois EPA Division of Legal Counsel File 98-06-AC, which relates to AC 06-50, *Illinois EPA v. Mark Gates*, for the purpose of determining the costs expended by Illinois EPA.
