### **NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE**

NOW COMES Petitioner, KCBX TERMINALS COMPANY (hereinafter "Petitioner"), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board in this proceeding until October 1, 2009. In support of this Notice, Petitioner states as follows:

- 1. On June 27, 2008, Petitioner filed a Petition for Review of the "Construction Permit Grant Operating Permit Denial NSPS Source" issued to Petitioner by the Illinois Environmental Protection Agency on May 23, 2008.
- 2. On July 29, 2008, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline for an Additional 70 Days, or until January 5, 2009.
- 3. On October 20, 2008, Petitioner filed a Notice of Waiver of 120-Day Decision Deadline for an Additional 70 Days, or until March 16, 2009.
