### **NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE**

Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board in this proceeding until March 18, 2010. - On June 27, 2008, Petitioner filed a Petition for Review of the
