**HEARING OFFICER ORDER**


On December 9, 2009, a telephonic status conference was held. The respondent did not appear. The petitioner represented that it is in settlement discussions with the respondent and that it will file an additional 60 day waiver of the statutory decision deadline.

The petitioner also noted that the above-captioned matter involves a construction permit, and not a CAAPP permit as stated in the November 19, 2009, Board order.

On December 15, 2009, the respondent's attorneys filed their appearances. Also on December 15, 2009, the respondent filed a motion for an extension of time to file the record in the above-captioned matter. To date, no response has been filed. The respondent's motion is granted to the extent that the record is now due to be filed on or before February 12, 2010.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 11, 2010, at 9:15 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




