

HEARING OFFICER ORDER

On December 17, 2009, all parties participated in a telephonic status conference with the hearing officer. Attorneys for the Illinois Attorney General’s Office (AGO) have now filed their appearances on behalf of the respondent, Illinois Environmental Protection Agency (Agency) and the attorneys for the Agency have withdrawn. The parties stated that they anticipate scheduling a meeting to discuss how to proceed. The petitioner stated that they may revisit the issue of the AGO’s representation at the next status conference. The petitioner represented that it will file an additional waiver of the statutory decision deadline.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 18, 2010, at 1:30 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


