The following respondents did not appear: Waste Hauling Landfill, Inc.; Jerry Camfield; Archer Daniels Midland, Inc.; Climate Control, Inc.; Bridgestone/Firestone, Inc.; General Electric Railcar Services Corporation; P & H Manufacturing, Inc.; Triple S Refining Corporation; and Zexel Illinois.
