


MOTION TO FILE REDUCED COPIES OF RECORD

Now comes the County Board of Macon County, Illinois by and through one of their attorneys, Larry M. Clark and moves this Honorable Board for permission to file a reduced number of copies of the record in the above referenced matter and states in support of said Motion as follows:

1. That the parties have agreed from time to time to extend the time for filing the record while discussing settlement of this appeal
2. That it appears that the Board is without the power to settle a local siting appeal without the filing of the record by the County.
3. That the County wishes to file a reduced number of copies, specifically:
 - a. One signed original hardcopy with full-size blueprints, including a thumb drive with 2.05 GB of information titled "Electronic Copies of Documents Submitted to the IEPA-Macon County Siting Application". - c. An electronic version on DVD or thumb-drive with all information, including the information entitled "Electronic Copies of Documents Submitted to the IEPA-Macon County Siting Application".


