HEARING OFFICER ORDER

On February 4, 2010, all parties participated in a telephonic conference with the hearing officer. Discussions centered on the motion in limine filed by the respondents. Among other issues raised in the motion, respondents contend that complainant and/or his former attorney informed them that complainant's expert witness, Greg Zak, was not going to testify at the hearing scheduled for February 23, 24 and 25, 2010. Based on that representation, respondents decided not to depose Greg Zak. The complainant stated that he nor his attorney ever represented that Greg Zak was not going to testify. The parties were directed to file affidavits, including complainant's former attorney, John O'Reilly, supporting the parties' respective positions. The parties were directed to file their respective affidavits on or before February 10, 2010. The respective affidavits were timely filed.

On February 16, 2010, all parties participated in a telephonic conference to discuss the affidavits and the status of the hearing scheduled for February 23, 24 and 25, 2010. After review of the affidavits, I found that there had been genuine miscommunications between the parties regarding the issue of whether or not Greg Zak was going to testify at the hearing. To that end, the previously scheduled hearing was cancelled. The parties were directed to agree on a date on which Greg Zak would be available for his deposition.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on February 25, 2010, at 1:00 p.m. The conference must be initiated by the complainants, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
