## PETITION FOR REVIEW OF FINAL DECISION

Now comes the Petitioner, GHS 630 LLC, by its attorneys, DiVincenzo Schoenfield Swartzman, and petitions the Board for review of a final decision by the Illinois Environmental Protection Agency, Respondent. In support of which, Petitioner states as follows:

- 1. Respondent made its final decision in a later dated January 21, 2010. (Attached as Exhibit A).
- 2. This letter was received sometime on or about January 25, 2010. It was also served as an attachment to an email dated January 25, 2010.
- 3. Petitioner was the owner of property located at 630 North McClurg Court in Chicago, Illinois.
- 4. On or about September 6, 2009, petitioner's environmental consultant discovered subsurface contamination of heating oil on the property and contamination of the groundwater on the

property with heating oil.

- 5. This contamination was located in close proximity to two underground storage tanks that had been used for heating oil and had been removed earlier in 2009.
- 6. Petitioner immediately began to respond to this incident. On November 6, 2009, it notified the appropriate authorities and was assigned the incident number LPC #0316085220.
- 7. On December 21, 2009, Petitioner submitted a 45-Day Report and a Free Product Removal Report to Respondent, with a request to be included in the Leaking Underground Storage Tank Program. These reports were received by Respondent on December 22, 2009.
- 8. Respondent's letter does not state the basis for its conclusion that the incident is not subject to the LUST Program.
- 9. On or about January 21, 2009, Petitioner's environmental consultant was told by a staff member working for Respondent, during a telephone call, that the basis of the denial would be that, at the time of the removal, the Chicago Department of Environment had determined that the tanks were not leaking.
- 10. At the time of the removal, Petitioner's agents saw holes in the tanks and saw staining around the tanks.
- 11. There is no other known or suspected source of the heating oil contamination, which is in very close proximity to the removed tanks.

WHEREFORE, Petitioner requests:

- A. A hearing to present evidence why this incident should be included in the LUST Program, and
- B. A finding reversing Respondent's Final Decision.



Dear Mr. Golub:

The Illinois Environmental Protection Agency (Illinois EPA) has reviewed the Free Product Removal Report (report) submitted for the above-referenced incident. This report dated December 21, 2009, was received by the Illinois EPA on December 22, 2009. Citations in this letter are from the Environmental Protection Act (Act) and 35 Illinois Administrative Code (35 Ill. Adm. Code).

Based on the information currently in the Illinois EPA's possession, this incident is not subject to 35 Ill. Adm. Code 734, 732 or 731. Therefore, the Illinois EPA Leaking Underground Storage Tank Program has no reporting requirements regarding this incident.

This letter, however, does not address whether any remaining contamination at this site is being managed to protect human health or the environment. Any remaining contamination not the subject of this letter may be subject to other provisions of the Act.

If you wish to address any remaining contamination, or portion thereof, at the site and want Illinois EPA concurrence that any cleanup measures taken are protective of human health, you may wish to consider participation in the Illinois EPA's Site Remediation Program. The Site Remediation Program has been developed to provide Illinois EPA guidance, assistance and determinations of successful completion for the voluntary conduct of remediation actions. The objectives of the program are as follows:

1. To provide Illinois EPA experience and assistance towards a timely, effective, and

resource efficient cleanup of soil and/or groundwater contamination; and

2. To provide proper conclusion of participation in the program resulting in the issuance of either a No Further Remediation letter or a Release of Responsibility letter by the Illinois EPA.

Under the Site Remediation Program the Illinois EPA is authorized, and may agree, to provide review and evaluation services for actions at sites where hazardous substances, pesticides or petroleum may be present for which the owner or operator requested such services in writing. Any other person similarly may request review and evaluation services for actions at the site so long as that other person has provided the Illinois EPA with the written permission of the owner or operator to conduct those actions. Participants in the Program are required to reimburse the Illinois EPA for such services.
