I note that you proposed withdrawal of the ECM exclusion on December 8, 2009. The comment period ended on January 22, 2010. Do you have any idea when a final rule may arise?

I am working on incorporation of the ECM exclusion into the Illinois regulations. If EPA is to withdraw the ECM exclusion sooner, rather than later, it could change the approach that I take to the amendments. I am compelled by State statute to adopt the ECM exclusion unless EPA is to adopt the withdrawal soon.
