## **HEARING OFFICER ORDER**

On June 22, 2009, Westwood Lands, Inc. (Westwood) filed an amended petition for an adjusted standard or, in the alternative, a finding of inapplicability. On January 7, 2010, the Board issued an opinion and order denying both Westwood's petition for an adjusted standard and its alternative request for a finding of in applicability.

After the Board granted an extension of the time to do so, Westwood on April 2, 2010, filed a motion for reconsideration of the Board's January 7, 2010 opinion and order (Mot.). In the motion, Westwood reports that its consultant, Civil & Environmental Consultants, Inc. (CEC), submitted 15 samples of steelmaking slag fines for laboratory analysis "using TCLP method 1311 (USEPA publication number EPA-530/SW-846)." Mot. at 4. Westwood included a summary of the results as Exhibit 1 to its motion for reconsideration. Mot., Exh. 1 (Report on Slag Sampling and Analysis). Westwood noted that "[t]he laboratory report and documentation for the Westwood sampling is 152 pages." Mot. at 4 n.6. Westwood indicated that, because it had provided a summary and in order to reduce the amount of paper used, it did not submit the full 152-page report. Id. However, Westwood stated that it "will provide that laboratory package upon the Board's (or Board staff's) request. . . . " Id.

To augment the summary it has provided as Exhibit 1, Westwood is directed to file the complete laboratory report and documentation for the TCLP testing summarized in Exhibit 1.
