**HEARING OFFICER ORDER**

On June 3, 2010, the following parties participated in a telephone status conference with the hearing officer: Complainant; A.E. Staley Manufacturing Co.; Aramark Uniform Services, Inc.; Borden Chemical Co.; Bridgestone/Firestone, Inc.; Climate Control, Inc.; Caterpillar, Inc.; Combe Laboratories, Inc.; and Trinity Rail Group, Inc.. The following respondents did not appear: Waste Hauling Landfill, Inc.; Jerry Camfield; Archer Daniels Midland, Inc.; Bell Sports, Inc.; General Electric Railcar Services Corporation; P & H Manufacturing, Inc.; Trinity Rail Group, Inc.; and Zexel Illinois.

By July 8, 2010, complainant will file a motion to voluntarily dismiss the action against Archer Daniels Midland, and will file an amended complaint to replace Zexel with its predecessor corporation. Complainant is negotiating settlement with the remaining respondents, except for Waste Hauling Landfill and Jerry Camfield. The stay of proceedings against Triple S Refining Corporation is extended to August 16, 2010.

The parties are directed to participate in a telephone status conference with the hearing officer at 2:30 p.m. on August 16, 2010. The call-in number is (213)270-2124, passcode 239550#.
