3	MS. WEBB: We'll go on the record. Good
4	morning, my name is Carol Webb. I'm a hearing officer
5	with the Pollution Control Board. This is AC 09-40
6	IEPA versus the Hills. It is June 8th. We are
7	beginning at 11 o'clock a.m. and there are no members
8	of the public present. At issue in this case is the
9	EPA's allegation that Respondents violated Sections 21
10	Pl and P7 of the Environmental Protection Act at a site
11	in Anna, Union County. The Pollution Control Board
12	members will make the final decision in this case. My
13	purpose is to conduct the hearing in a neutral and
14	orderly manner so that we have a clear record of
15	proceedings. This hearing was noticed pursuant to the
16	act in the Board's rules and will be conducted pursuant
17	to Sections 101.600 through 101.632 of the Board's
18	procedural rules. At this time, I will ask the parties
19	to please make their appearances.
20	MS. RYAN: Michelle Ryan, Special Assistant
21	Attorney General for the Illinois EPA. I have my
22	formal appearance, the original is on the top, and ten
23	copies on the bottom.
24	MS. WEBB: And Mr. and Mrs. Hill, you are

- both here pro se, is that correct, representing
- 2 yourselves?
- 3 MR. HILL: Yes.
- 4 MRS. HILL: At this time.
- 5 MS. WEBB: Okay.
- 6 MRS. HILL: That may change.
- 7 MS. WEBB: Well, this is the hearing so you
- 8 are here representing yourselves today.
- 9 MRS. HILL: Okay. Then I think we need to
- 10 stop and we will contact a lawyer. Thank you.
- MS. WEBB: No, this is going to be the
- 12 hearing. I hope you will stay, but we are going to do
- 13 the hearing. We just drove 220 miles so we are doing
- 14 the hearing today.
- MRS. HILL: Yeah, but we feel we cannot
- 16 represent ourselves at this time possibly so I think we
- 17 have the right to a lawyer because we can no longer

- 12 DIRECT EXAMINATION
- 13 BY MS. RYAN:
- Q. Can you state your name and spell it for the
- 15 court reporter, please.
- 16 A. Sheila Williams, it's S-H-E-I-L-A
- W-I-L-I-A-M-S.
- 18 Q. What is your job?
- 19 A. I am an enrivonmental protection specialist
- 20 with the Illinois Environmental Protection Agency.
- Q. Which office do you work out of?
- 22 A. Marion.
- Q. How many years have you been a field
- inspector for the Environmental Protection Agency?

- 1 A. I have worked in this capacity at the Marion
- 2 office for about 17 years.
- 3 Q. What are your duties as an environmental
- 4 protection specialist?
- 5 A. I conduct field inspections which would
- 6 include solid waste, tires, RCRA, which is R-C-R-A,
- 7 which are like hazardous waste inspections, do the
- 8 field work and then generate reports.
- 9 Q. Over your 17 years as a field inspector,
- 10 approximately how many inspections have you conducted?
- 11 A. Well over a thousand.
- 12 Q. What's your educational background?
- 13 A. I have a Bachelor's degree in biology.
- 14 Q. From?
- 15 A. Greenville College.
- 16 Q. Have you had any additional training besides
- 17 your Bachelor's degree?
- 18 A. A variety of training, yes.
- 19 Q. Anything related to your job in particular?
- 20 A. Yes. I'm sorry.
- Q. That's okay.
- 22 A. The HAZWOPER training, which is dealing with
- 23 hazardous waste operations, a variety of topics,
- including but not limited to methamphetamine awareness,

- 1 geology, hydro-geology, ground water chemistry,
- 2 landfills are some of them.
- Q. Okay. Are you familiar with the facility
- 4 known as Lot 18 Agnes, Ussery, I'm going to say Ussery
- 5 because I'm not sure --
- 6 MRS. HILL: Ussery.
- 7 Q. Ussery, U-S-S-E-R-Y is the spelling,
- 8 addition in Anna?
- 9 A. Yes, I am familiar with it.
- 10 Q. Where is that property located?
- 11 A. It is in the southwest portion of Jonesboro,
- 12 I'm sorry, Anna.
- Q. Who owns that property?
- 14 A. I believe it's Thomas and Valerie Hill.
- 15 Q. How many inspections have you conducted
- 16 there at that property?
- 17 A. Three total.
- 18 Q. I'm going to hand you what I've marked for
- 19 identification as Exhibit 1. Can you tell me if you
- 20 recognize that document?
- 21 A. Yes, I do.
- Q. What is it?
- 23 A. It's a narrative inspection package that I
- wrote following the March 4th, 2009 inspection.

- 1 Q. Can you page through that for me, please?
- 2 A. Sure.
- 3 Q. Is that a fair, accurate and complete copy
- 4 of your report?
- 5 A. I believe so.
- 6 Q. Can you describe the property generally?
- 7 A. It sits on the south side of, I'm sorry, is
- 8 it Ussery Street; is that correct?
- 9 MR. HILL: Yes.
- 10 A. Sits on the south side of Ussery Street and
- 11 there is a mobile home on that lot.
- 12 Q. Who took the photographs that are attached
- 13 to this report?
- 14 A. I did.
- 15 Q. And starting with Photograph No. 1, can you
- tell us what they show, please?
- 17 A. There is a dilapidated mobile home that
- 18 shows that the interior is exposed.
- 19 Q. And moving to picture number two, can you
- 20 describe that picture?
- 21 A. And toward the south end of that mobile
- 22 home, there was a pile of demolition debris on the
- ground to the south of it that you could sort of see
- through this picture.

- 1 Q. Is it -- can you identify in relation to the
- other -- can you identify this pile in this picture?
- 3 It's a little difficult to see with the branches and
- 4 stuff.
- 5 A. Right. It appeared to be demolition debris,
- 6 probably consisting of mostly demolition wood.
- 7 Q. I'm seeing sort of a white patch right about
- 8 in the middle of the photograph. Is that the pile you
- 9 are describing?
- 10 A. Yes. Yes.
- 11 Q. And the material on the left is the actual
- mobile home that was pictured in the photograph left?
- 13 A. Yes, the far left --
- 14 Q. Okay.
- 15 A. -- was the mobile home.
- Q. Okay. Photograph 3.
- 17 A. Okay. Three, it is the central part of the
- 18 mobile home and it appears that if there is any part of
- 19 a roof there, it's fallen in and obviously the sides of
- it has fallen in on itself.
- 21 Q. And there is a brown wall toward the top of
- 22 the photograph. Is that part of the mobile home or is
- 23 that a different structure there?
- A. That's the interior of the same mobile home.

- 1 Q. Got you. Number four.
- 2 A. Number four, to the back of that area again
- 3 is the same pile of demolition debris that we saw in
- 4 Photograph 002.
- 5 Q. And is that right in the center of the
- 6 photograph?
- 7 A. Yes, it is, it's on the ground.
- 8 Q. And number five.
- 9 A. That would be what I would consider the
- front or the north end of the mobile home. Again, it
- shows that the interior of it is exposed and there are
- 12 also a variety of items on the porch.
- Q. Can you identify any of those items?
- 14 A. There is a vehicle battery, a couch, and
- 15 I -- it looks like maybe a piece or two of furniture, I
- 16 can't tell for sure.
- 17 Q. And number six.
- 18 A. And then number six is that same pile of
- demolition debris that was observed in Photos 002 and
- 20 004.
- 21 Q. Do these photographs accurately depict what
- you saw at the property on March 4th, 2009?
- 23 A. Yes, they do.

- 9 please.
- 10 VALERIE HILL, produced, sworn and examined
- as a witness, testified and deposed as follows:
- 12 DIRECT EXAMINATION
- 13 BY MRS. HILL:
- 14 MRS. HILL: We were contacted by the EPA
- 15 that we needed to clean up our property at 100B Ussery
- 16 Street. At the time my husband was unemployed. He was
- 17 unemployed until three weeks ago, the exact date I'm
- 18 not sure. We are financially strapped. We can hardly
- make our bills, and the EPA was wanting to impose a
- 20 fine and citation on us if we didn't get it cleaned up.
- 21 We tried to explain our circumstances and let them
- 22 understand that we would be trying to do what we could,
- 23 but until we had financial ability, it was kind of hard
- 24 to hire, bring in equipment, do anything with the

- debris that was left on our lot. The debris left on
- this lot, we had offered a business to remove two
- 3 trailers from Lot 17 and Lot 18 for the metal. They
- 4 were to remove, totally remove everything off our lots
- for the cost, you know, for the scrap metal. In the
- 6 middle of it, this last trailer, they left. Our Lot 18
- 7 trailer, they left. We got it cleaned up. In the
- 8 middle of our cleaning, the City of Anna closed down
- 9 Baker Street which is a legal, at that time was a legal
- 10 road that we were using to clean up the debris and
- 11 remove it. At the time that they closed down the
- 12 entranceway to Baker Street, we have been in litigation
- trying to get it open so we can continue our cleanup
- 14 from our garage parking lot on Baker Street. This has
- 15 been going on since 2007. We have exhausted all our
- 16 credit cards. We are almost at a bankruptcy state with
- 17 all of our truck and our home and we have tried to
- 18 explain this to the EPA. We have tried to get them to
- 19 understand. We are a victim here because these people
- 20 left this debris on our property. The City of Anna and
- 21 Mr. Stokes who had the road entrance closed on Baker
- 22 Street, we don't know what to do. We've been fighting
- 23 it since 2007. We are still in litigation on it and
- 24 they want us to remove evidence for a case that we are

1	in	litigation	on.	and I	think	as	long	as	we	have	the

- 2 need of evidence and proof for a court litigation that
- 3 is active, we should not have to remove such debris
- 4 until our court case is resolved. And we have tried to
- 5 negotiate and work with them, even tried to rearrange
- 6 court dates to accommodate my husband getting a new job
- 7 so he doesn't lose his pay so that we can afford to
- 8 clean up our lot when we possibly get the road to Baker
- 9 Street reopened, but at this time, they are not willing
- 10 to cooperate and help us.
- MS. WEBB: Ms. Ryan?
- 12 CROSS-EXAMINATION
- 13 BY MS. RYAN:
- Q. Ms. Hill, you said you offered a company to
- take the material off the site for the metal. What
- time -- when was that?
- 17 A. The summer of 2007.
- 18 Q. And is that --
- MRS. HILL: What was the company name?
- 20 MR. HILL: Truly Blessed, Incorporated.
- 21 Should have knowed better, just like buying a vehicle
- 22 off a priest.
- Q. And when did you say Baker Street was
- 24 closed?

- 1 A. Baker Street was initially shut down in
- 2 November of 2009. They --
- 3 Q. 2009?
- 4 A. 2007.
- 5 MR. HILL: They've had it blocked off since
- 6 2007.
- 7 A. 2007. Yeah, I'm sorry.
- 8 Q. That's all right.
- 9 A. We've been dealing with a lot of stress over
- 10 this matter.
- 11 Q. You had previously told me that the case
- 12 number was 09-LM-3. Is that still your pending case
- 13 number?
- 14 A. I couldn't even tell you what our case
- 15 numbers are at this time. We have dealt with so much.
- Q. But do you have a pending case?
- MR. HILL: Yes.
- 18 A. We do have pending cases still.
- 19 Q. And that case has not been dismissed?
- MR. HILL: No.
- 21 A. No cases have been dismissed that I know of.
- 22 Q. Because you had discussed with me previously
- that cases had been dismissed; Union County kept
- 24 dismissing our case, you said.

- 14 will swear you in, you may make a statement.
- 15 THOMAS HILL, produced, sworn and examined as
- 16 a witness, testified and deposed as follows:
- MS. WEBB: Go ahead.
- 18 MS. RYAN: You get to question yourself
- 19 so --
- 20 MS. WEBB: You can just make a statement.
- 21 DIRECT EXAMINATION
- 22 BY MR. HILL:
- 23 MR. HILL: It's just the fact that I'm not
- good with words. You are going to have to bear with me

- 1 while I put them in place.
- MS. WEBB: Okay.
- 3 MR. HILL: You've got them pictures?
- 4 MS. RYAN: She has them.
- 5 MR. HILL: There is on this road, Ussery
- 6 Street, which is really an alley, you can see right
- 7 there where my son's trailer almost went off in the
- 8 neighbor's yard. You can see how far the road has fell
- 9 in.
- MS. WEBB: Hang on. What are these
- 11 pictures?
- MR. HILL: This is Ussery Street.
- MS. WEBB: Are these --
- MR. HILL: This is road access to the
- 15 trailers. Right here sits one trailer and right here
- 16 sits the other on this road. You can see where our
- 17 trailer that's the new trailer -- well --
- 18 MRS. HILL: I don't have that shot.
- 19 MR. HILL: There is a trailer sitting right
- 20 here on the first lot. You can see where the trailer
- 21 almost went in the neighbor's yard, the road give away.
- 22 You can see how far, how much road is left. I will not
- ask anybody to back a truck in there with a dumpster
- 24 knowing the fact that that road can fall over and they

- 1 end up on their top. When you go right past this road
- 2 right here, there was Baker Street. The road that we
- 3 was using, I've owned the place since '04, been in and
- 4 out of it every year --
- 5 MRS. HILL: Of '94.
- 6 MR. HILL: -- every week; oh, '94, excuse
- 7 me, in the middle of cleaning up because we had two old
- 8 trailers that weren't fitting, in my opinion, they
- 9 weren't fitting for my granddaughter to live in.
- 10 That's who is living there, my son, his girlfriend and
- 11 my granddaughter. Well, we tried to give the trailer
- 12 away. Well, couldn't do that. So this company
- approached me, said we will clean it up, we'll tear
- them down, clean them up, forward them out. I said,
- 15 that's fine. Well, you see what they left us. Well, I
- started cleaning it up. Well, the neighbor down here,
- 17 Mr. Stokes, I don't know what happened, I don't know
- 18 why, I don't care, he gets the city to shut down our
- 19 access, which through a bunch of lies the mayor looked
- 20 me right in the eye, told me there was no way I drove
- 21 my truck in and out of there, and I have since '94
- 22 every week because I took my truck and trailer in there
- 23 and mowed my yard and all of a sudden there is no --
- 24 not to mention the fact that the little bitty cubby

- 1 hole that they say we have access to this Lot 18, there
- is no room for a dumpster. If we put a dumpster in
- 3 there, my son has no place to park his vehicle. We
- 4 don't have no place to park to do anything once the
- 5 dumpster is in there. The road is not wide enough for
- 6 two vehicles to pass. It's an alley. It's not a road.
- 7 MRS. HILL: Never was originally.
- 8 MR. HILL: Now, I'm in one of those catch
- 9 22's. What do I do? Do I -- would you, put yourself
- in my position; would you have a man knowing that that
- 11 road will fall through again because that big truck and
- 12 a dumpster weighs a lot more than that trailer does,
- 13 now any of you'nse, would you put a man's life at risk
- 14 over that?
- 15 MS. WEBB: Well, I can't answer that, but is
- 16 that -- do you have anything more to add or --
- 17 MR. HILL: Well, just that I think it's all
- 18 bogus. I don't think there is a place -- why does a
- 19 man not have a right to defend himself against --
- 20 because I know who done it; I know the City of Anna
- 21 done it because we put the lawsuit against them over
- this road closure and I think it's bull. That's all I
- got to say, it's bull.
- MS. WEBB: Ms. Ryan?

- 1 MRS. HILL: It's discrimination.
- 2 MR. HILL: I've tried, I've tried to do
- 3 everything; I've done everything, tried to follow the
- 4 letter of the law and do what's right.
- 5 MRS. HILL: And we were cleaning.
- 6 MR. HILL: That's what I get out of this;
- just do I guess whatever you want.
- 8 MS. WEBB: We'll just follow up if you have
- 9 any other questions.
- MS. RYAN: Mr. Hill, are you planning to
- introduce those pictures into evidence? Because I do
- 12 have some questions about them.
- MR. HILL: Yeah, I will.
- MS. RYAN: Then you need to give them to the
- hearing officer then and then I don't have any
- objection to admitting them then.
- MS. WEBB: Okay.
- 18 MR. HILL: But right here is even a better
- 19 picture of where the road has fell in, you can see the
- 20 rip-rap, you can see where they put concrete slats to
- 21 try to hold it up.
- 22 MS. WEBB: I'll let you ask your questions.
- 23 CROSS-EXAMINATION
- 24 BY MS. RYAN:

- 1 Q. Mr. Hill, did you take these photographs
- 2 here? There looks to be --
- 3 A. My wife just took them.
- 4 Q. Hold on, let's see here, there looks to be
- 5 seven photographs and you took -- Ms. Hill, you took
- 6 all of these photographs?
- 7 MRS. HILL: I took them, yesterday and this
- 8 morning.
- 9 O. Yesterday and this morning. And this is the
- 10 current condition of Ussery Street; is that correct?
- 11 A. Yeah.
- 12 O. Is Baker Street visible in any of these
- photographs anywhere?
- 14 A. No.
- 15 MRS. HILL: No, I didn't get my pictures, I
- didn't even think to print them this morning. On your
- 17 sample here, Baker Street was an unimproved street. It
- 18 was established, I've got a, in my abstract, it was
- 19 established in like, and it's down at the Union County
- 20 Courthouse, it's in their description thing. It was
- originated like in the late 1890s, early 1900s. It
- 22 was, it was a street then.
- 23 O. Uh-huh.
- MRS. HILL: Through the years, the City of

- 1 Anna didn't maintain it.
- Q. Uh-huh.
- 3 MRS. HILL: It has always been a open
- 4 street. It had never been closed down, no legal
- 5 documentation up until December of 2 -- well, November
- of 2007 when they chose to vacate it for Mr. Stokes'
- 7 beautification purposes. At that time -- I've lost
- 8 track of what I was thinking of.
- 9 MS. WEBB: What were you asking about the
- 10 pictures?
- 11 MS. RYAN: I was just asking if you could
- see Baker Street in the picture so I was going to let
- her go.
- MS. WEBB: So no.
- MRS. HILL: At that time, our street looked
- like these pictures that you have on your thing. Where
- 17 are my pictures at? You can kind of see on exhibit --
- 18 MR. HILL: Right there.
- 19 MRS. HILL: This one here?
- MS. RYAN: That's Exhibit 1, Photograph 6
- 21 you are talking about.
- 22 MRS. HILL: This is our -- right there is
- our garage roadway. Now she took these in 2009.
- MS. RYAN: And you are drawing through the

- 1 middle of the picture. I need to get that on the
- 2 record because they can't see what you are doing there.
- 3 MRS. HILL: And we took these in, when,
- 4 2009?
- 5 MS. WILLIAMS: Uh-huh.
- 6 MRS. HILL: See how much the grass has
- 7 growed up and died, all of this right here is a road.
- 8 MR. HILL: Rock base.
- 9 MRS. HILL: Since 2007 to 2009, that grass
- 10 has growed up over the gravel that they -- we have
- 11 there because they never, even though they get taxes
- for roads, they never ever improved our road to be
- 13 blacktopped, to be graveled and chipped, and then they
- 14 come in and they close the road down on us and now the
- pictures that I have today, if I had brought them in
- and will show you a very large difference in the grass
- 17 because the grass is thick and really, really, really
- 18 very green now.
- 19 MS. RYAN: In Photograph 6, you are coloring
- about the bottom half inch of the page there.
- 21 MRS. HILL: This is the road that was there.
- MS. RYAN: You are saying that is Baker
- 23 Street or that's a different road?
- MR. HILL: This is Baker Street.

- 1 MS. RYAN: That is Baker Street shown in the
- 2 bottom of Photograph 6.
- 3 MRS. HILL: Right.
- 4 MS. RYAN: Got you.
- 5 MRS. HILL: It's actually the frontage road
- for Lot 18 because that's where our garage entrance is.
- 7 Lot 18 does not really have a frontage entrance on
- 8 Baker Street. It just has --
- 9 MR. HILL: On Ussery Street.
- 10 MRS. HILL: On Ussery Street. It just has
- 11 property abutting it. Our actual entranceway is off of
- 12 Baker Street that they closed down.
- 13 MS. RYAN: And your garage, is that shown in
- 14 any of the photographs that you have anywhere -- that
- we have?
- MRS. HILL: That you have here.
- MS. RYAN: The thing underneath the trailer,
- 18 got you.
- 19 MRS. HILL: It's like, what, a 25 --
- something like a 25 by 50 garage.
- MR. HILL: It's about a 24 by 60.
- 22 MS. RYAN: So there is doors on the opposite
- 23 side away from the photograph?
- MR. HILL: Yeah.

- 1 MRS. HILL: Uh-huh.
- MS. RYAN: I got it now. And, Mr. Hill, you
- 3 said your son and his girlfriend and your granddaughter
- 4 live on the property. You are not referring to the
- 5 picture there, okay.
- 6 MR. HILL: Not this one --
- 7 MRS. HILL: Lot 17.
- 8 MR. HILL: Right here is their trailer.
- 9 That's first in line.
- 10 MS. RYAN: Photograph 4 in Exhibit 1, the
- 11 little white one on the left side there. Okay.
- MR. HILL: See if you was coming in this
- way, it would be their trailer first and then the
- 14 second trailer.
- 15 MS. RYAN: Okay. I think that's all I have.
- MS. WEBB: Okay. Thank you.
- MS. RYAN: And I have no objections to
- 18 admitting these. I don't know if you want to try and
- 19 number them or --
- MS. WEBB: No, I'm just going to put them
- 21 together as Exhibit 2.
- MR. HILL: Wonder what they are doing with
- 23 the flags now all of a sudden? Of course these
- 24 pictures tell the story whether they changed it or not.

- 1 MRS. HILL: No, Thomas said that Frank was
- 2 planting some kind of flowers or something.
- 3 MR. HILL: I hadn't seem them --
- 4 MRS. HILL: He's putting decorations around.
- 5 MS. WEBB: Did you have anything else, any
- 6 other questions?
- 7 MS. RYAN: Not for Mr. Hill, no.
- 8 MS. WEBB: So we are done with Mr. Hill as
- 9 well?
- 10 MS. RYAN: Yes. I did have more questions
- 11 for my inspector.
- 12 MS. WEBB: Okay. Then I will let you recall
- 13 your inspector.
- 14 MS. RYAN: I will recall Sheila Williams.
- 15 REDIRECT EXAMINATION
- 16 BY MS. RYAN:
- 17 Q. Sheila, you said you are standing there on
- 18 Ussery Street when you took these photographs. From
- 19 where you were standing, is there any way for the Hills
- 20 to remove the material on the property that you are
- 21 concerned about without accessing the Baker Street
- which they apparently don't have access to any longer?
- 23 A. Yes, I believe so.
- Q. And how, how would that -- how could that

- take place? How could that physically happen? I
- 2 understand their financial concerns.
- 3 A. Right.
- 4 Q. But how physically could that be taken care
- 5 of?
- 6 A. Ussery Street is, from when I was there, I
- 7 believe the last time I was there was October of 2009,
- 8 it appeared to be a residential area with several homes
- 9 on it, people coming and going. It appeared that the
- 10 road is used on a regular basis. I agree in the sense
- 11 that I would -- I don't think it's a good idea to try
- 12 to get some kind of heavy large equipment in there, but
- 13 from what I have seen, vehicles do travel that road on
- 14 a routine basis and a pickup truck, utility trailer
- 15 probably get in there and --
- MR. HILL: You got one I can borrow?
- MS. WEBB: Mr. Hill, please.
- 18 A. -- and work on it, you know, it might not be
- 19 as feasible, but it could get done by using those types
- of things. You could use Ussery Street just with a
- 21 pickup truck for most of the debris.
- MS. RYAN: Thank you. That's all I have.
- MS. WEBB: Mrs. Hill?
- 24 RECROSS EXAMINATION

1	BY MRS. HILL:
2	MRS. HILL: She says that we could use a
3	pickup truck and a trailer. If you will note in my
4	pictures, if I were to park a trailer there alongside
5	the road, no one would be able to enter or exit past my
6	vehicle. Let it be known that yes, there is a
7	residential area but you are talking once again in my
8	Exhibit 2, my car shows you there is no way two
9	vehicles can legally go through that road at the same
10	time without pulling off into my Lot 17 driveway or in
11	a ditch or in the neighbor's driveway to allow a
12	vehicle to pass so that you can pass after they pass.
13	Two vehicles cannot enter and exit on that road at the
14	same time and it is not feasible to stick a truck or a
15	trailer on the side of the road when it's the only way
16	a vehicle can enter and exit that road.
17	MS. WEBB: Okay.
18	MRS. HILL: Plus
19	MS. WEBB: Did you want to see
20	MRS. HILL: Let me think, go ahead. I had
21	something else on my mind. Trying to think of it all,
22	I can't keep it clear.

MS. WEBB: Um -- okay.

MRS. HILL: I know. Plus the trailer, it is

- 1 the debris of a trailer which it is mostly wood that's
- 2 left because obviously they took all of the valuable
- 3 stuff off of it; and the axles, I would like to know
- 4 how Mrs. Williams expects us to move a -- how long is
- 5 it, 25 foot?
- 6 MR. HILL: 48 foot.
- 7 MRS. HILL: -- 48-foot trailer frame on a
- 8 truck and a trailer.
- 9 MS. WEBB: Okay. Well, I'll assume that's a
- 10 hypothetical question that you are posing to the Board
- 11 for their consideration.
- 12 MRS. HILL: Well, she's got ideas so, yeah,
- 13 I want to know how she's going to get it removed. Plus
- I also want to know is if you guys put these fines on
- 15 us, are these, the money that we may have to pay for
- these fines, do they go to cleaning up my property,
- 17 because I still cannot afford to pay for it if you fine
- 18 me and take the money that I already don't have to pay
- 19 to get it cleaned up, let alone the fines. Is my money
- 20 that you get from me on this fine going to come out
- 21 there and clean up my property for me?
- MS. WEBB: Well, we can talk about -- I
- 23 actually have no idea where that money goes. I never
- 24 see any of it.

- 1 MS. RYAN: It goes into an environmental
- 2 protection trust fund so maybe eventually you might see
- 3 a piece of it.
- 4 MRS. HILL: So technically my money goes
- 5 into a fund and it pays your salaries; it don't come
- out and pay to clean up my property?
- 7 MS. RYAN: No, it does not pay my salary.
- 8 My salary is paid elsewhere.
- 9 MRS. HILL: Thank you, I understand.
- 10 MS. RYAN: The statute requires that
- 11 penalties from administrative citations be placed into
- 12 the environmental protection trust fund. It's in
- 13 Section 482 of the Environmental Protection Act, I
- forget which subsection, but whichever, B5 maybe, B4,
- 15 5. I don't have it in front of me, but it does require
- that the penalties be placed in the environmental
- 17 protection trust fund, which does support the boards
- 18 IDNR and Illinois EPA and the Attorney General's
- 19 Office.
- 20 MRS. HILL: But it doesn't come and help me
- 21 clean up my property?
- MS. RYAN: That's correct.
- 23 MS. WEBB: Mrs. Hill, I think we've covered
- 24 everything we need to cover for your appeal on your

1	property.
2	MRS. HILL: I still am a victim.
3	MS. WEBB: No one is making any closing
4	arguments?
5	MS. RYAN: No, I'll reserve that for my
6	brief, thank you.
7	MS. WEBB: The transcript of these
8	proceedings will be available from the court reporter
9	by June 18th and will be posted on the Board's website.
10	The public comment deadline is June 22nd. Any public
11	comment must be filed in accordance with Section
12	101.628 of the Board's procedural rules. The
13	Complainant's brief is due by July 9th and the
14	Respondent's brief if they choose to file one is due by
15	August 9th. At this time, I will conclude the
16	proceedings and we stand adjourned.
17	(The hearing was adjourned at 11:30 a.m.)
