# CORTLAND TOWNSHIP SPECIAL MEETING May 18, 2010 14 S. Prairie Street, Cortland, IL 60112

## CALL TO ORDER:

Clerk Julie Ross called the meeting to order at 7:05 pm. There were 191 registered voters and 23 non voters for a total attendance of 214.

#### PLEDGE:

Everyone stood and recited the Pledge of Allegiance.

#### **COMMENTS:**

Clerk Julie Ross instructed that those wearing non-voter name tags would not be able to comment or vote. Those wearing blue voter name tags would be able to comment and vote.

## **ELECT MODERATOR:**

Roger Steimel made a motion to elect Frankie Benson as Moderator, Barb Potuznik seconded the motion, all were in favor and Frankie Benson was elected Moderator of the meeting. The moderator stated that according to citation 60ILCS Townships, Special Meetings, that the required quorum of 15 or more had been met.

ILLINOIS TOWNSHIP CODE (60ILCS 1/30-120). GARBAGE: Richard Hahin moved that the electors of Cortland Township adopt the following resolution:

# I move that we, the Electors of Cortland Township, adopt the following resolution:

Whereas the Cortland Landfill is located in Cortland Township of the County of DeKalb in the State of Illinois; and

Whereas Waste Management of Illinois, Inc. as owner/operator of said landfill has applied for the major expansion of the landfill, including the size of the facility, the amount of waste to be accepted at the landfill, and the geographic origination of which to haul the waste from; and Whereas Waste Management of Illinois, Inc. has filed a Siting Application with the State of Illinois; and

Whereas Waste Management of Illinois, Inc. has purposed a Host Agreement with the DeKalb County Board to allow such expansion; and

Whereas Waste Management of Illinois, Inc. has entered into a financial agreement with the Town of Cortland in exchange for non-resistance or assistance to any other parties' resistance to said landfill expansion plans; and

Whereas Cortland Township has the authority to accept or deny any such refuse disposal facilities under the Illinois Township Code (60 ILCS 1/30-120) Sec. 30-120.

Garbage. The electors may prevent the deposit of night soil, garbage, or other offensive substances within the limits of the township. This Section does apply to refuse disposal facilities regulated by the Illinois Department of Public Health and the county in which the facilities are located. (Source: P.A. 82-783; 88-62.);

Be it therefore resolved by a vote of the Electors of Cortland Township that no expansion of the Cortland Landfill will be allowed in Cortland Township- in size of the facility, in the amount of waste material accepted at the facility, or in the origination points from which waste is hauled from.

Joseph Kirchens seconded the motion; the floor was opened for discussion and limited to three minutes per person.

Richard Baker asked if Waste Management would be setting the tipping fee for the 42 years of the proposed Landfill agreement. No one responded to the question.

Robert Benson made a motion to amend the resolution by striking out all reference of Cortland Landfill and inserting DeKalb County Landfill, David Yeager seconded the motion and the floor was opened for discussion. The question was asked if the person who made the original motion was in favor of the changes. Richard Hahin was in agreement with the changes. Lee Ann Brei made a motion to strike the last word (from) of the resolution, and place the period behind the word hauled, Richard Hahin seconded the motion, all were in favor and the motion passed.

Frankie Benson read the revised resolution:

Whereas Cortland Township has the authority to accept or deny any such refuse disposal facilities under the Illinois Township Code (60 ILCS 1/30-120) Sec. 30-120.

The motion was approved by a majority vote of the Electors.

Joseph Kirchens made a motion to adjourn the meeting, Diane Ledbetter seconded the motion, all were in favor and the meeting was adjourned at 7:28 pm.
