



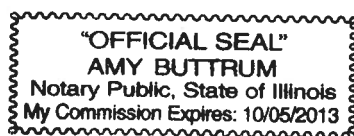

MOTION FOR AN EXTENSION OF TIME

NOW COME the Respondents, GARY D. HILL, VILLA LAND TRUST, an Illinois Land Trust, and PRAIRIE LIVING WEST, LLC, by and through their attorneys Winters, Brewster, Crosby and Schafer LLC, and respectfully request that the Board grant an extension of time up to and including July 31, 2010, to file a responsive pleading to Complainants' Complaint, and in support thereof, hereby state as follows:

1. Complainants filed their Complaint on or about June 1, 2010, alleging various water and land violations allegedly committed by Respondents.
2. Respondents were served on or about June 1, 2010.
3. The Illinois Environmental Protection Agency conducted a survey at the Respondents' site on June 10, 2010. The IEPA is expected to render its findings during that survey at some later date. The IEPA's findings may warrant the filing of a motion to dismiss based upon the Complaint being duplicative or frivolous, or other similar motion. Regardless, the IEPA's findings will be relevant in Respondents' preparation of a responsive pleading to the

Complaint.

4. According to 35 Ill. Adm. Code 103.212(b), motions made by respondents alleging that a citizen's complaint is duplicative or frivolous must be filed no later than 30 days from the date of service on the respondents.


4. Therefore, respondents are required to make such a motion no later than July 1, 2010.

4. Respondents request an extension of time for 30 days, up to and including July 31, 2010, to stay the 30-day filing period.


