HEARING OFFICER ORDER

On July 7, 2010, the parties and intervenor participated in a telephone status conference with the hearing officer. The parties report that progress has been made on some issues, but that this case is likely to go to hearing. American Bottom Conservancy (ABC) does not believe that sufficient progress has been made, and wants to set a hearing date as soon as possible. Assuming deadline waivers are filed, the hearing officer advised ABC that a hearing date would not be set until the parties were prepared to go to hearing. The parties are meeting with ABC next week to advise them of progress made, and to discuss outstanding issues. Petitioner agreed to file a deadline waiver to December 2, 2010.

The parties are directed to participate in a telephone status conference with the hearing officer at 11:00 a.m. on August 24, 2010. Petitioner will set up a conference call-in number.

The decision deadline is currently October 21, 2010.
