
HEARING OFFICER ORDER

On August 19, 2010, all parties participated in a telephonic status conference with the hearing officer. The parties represented that they intend to initiate settlement discussions. The petitioner stated that it will file an additional 70 day waiver of the statutory decision deadline.

Respondent's motion for leave to file reduced number of copies of record, filed July 26, 2010, was also addressed. Petitioner stated that it had no objection. Respondent's motion is granted.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 30, 2010, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


