2. Under 35 Ill. Admin. Code 101.500(d), Complainants are granted fourteen (14) days from receipt of the Motion to file a Response.

4. 
5. Under 35 Ill. Admin. Code 101.500(d) and 101.522, Complainants may request an extension of time to respond.
