HEARING OFFICER ORDER


On August 25, 2010, all parties participated in a telephonic status conference with the hearing officer. The parties discussed scheduling depositions, which could include depositions extending into October, 2010. To that end, the tentative hearing dates scheduled for mid-October will have to be rescheduled, with Waste Management of Illinois filing an additional waiver of the statutory decision deadline.

The motion to file a reduced number of copies of the record filed by the County Board of DeKalb County (County) on July 2, 2010, was also discussed. In the motion, the County requests that it be allowed to only file an original of the hard copy of the record of the proceedings along with two sets of discs containing an electric version of the record.

The County's motion was granted to the extent that the County was directed to file the original hard copy of the record, one hard copy of the record and one electronic version of the record with PCB 10-103. The County was further directed to file two hard copies of the record and one electronic version of the record in PCB 10-104.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 16, 2010, at 2:00 p.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




