
HEARING OFFICER ORDER

On September 16, 2010, all parties participated in a telephonic status conference with the hearing officer. The parties discussed extending the discovery cut-off date, including depositions. By agreement, the discovery cut-off date is now October 29, 2010. Any pre-hearing motions are due to be filed on or before November 5, 2010. Any responses are due to be filed on or before November 8, 2010. The aforementioned dates may be revisited at the next telephonic status conference.

To that end, tentative hearing dates were scheduled for November 22 and 23, 2010. The petitioner, Waste Management of Illinois, stated that it will file an additional waiver of the statutory decision deadline to at least February 3, 2011.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on October 7, 2010, at 1:30 p.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


