(1) On August 9, 2010, Illinois EPA issued an Administrative Citation to two Respondents, Marion Metal & Roofing and C & T Recycling, based on an inspection conducted on July 1, 2010.

(2) On September 13, 2010, both Respondents filed separate petitions for review contesting this Administrative Citation.

(3) Among the issues raised in the petition for review filed by Marion Metal & Roofing is that it is not the current owner of the property.
