HEARING OFFICER ORDER

On October 12, 2010, the parties participated in a telephone status conference with the hearing officer. The parties agree to the following deadlines:

Respondent North Fork Pork, LLC shall have until November 15, 2010 to file a motion to attack the sufficiency of the pleadings. Complainant shall have until December 3, 2010 to respond.

The remaining respondents requested leave to reply to complainant's response to the motion for partial dismissal and the motion to dismiss and/or strike. Complainant objected, but the hearing officer granted respondents until October 21, 2010 to reply. Complainant was granted leave until November 5, 2010 to file a surreply.

If the Board rules on all outstanding motions in the same order, all parties shall have 30 days from the Board's ruling to answer the complaint. If the Board rules on these motions separately, the hearing officer will issue an order clarifying each party's deadline for answering the complaint.

The parties are directed to participate in a telephone status conference with the hearing officer at 2:00 p.m. on December 6, 2010. The status conference shall be initiated by the complainant.
