

HEARING OFFICER ORDER

On October 14, 2010, a telephonic status conference was held. Respondent did not appear due to a scheduling conflict. The petitioners also stated that they will file an additional 90 day waiver of the statutory decision deadline.

The parties are directed to participate in a telephonic status conference with the hearing officer on December 9, 2010, at 1:30 p.m. The status must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.


