

HEARING OFFICER ORDER

On October 19, 2010, the petitioner's filed a motion for an extension of time to respond to respondent's motion for summary judgment. During an October 25, 2010, conference call, the respondent's stated that it had no objection to petitioner's motion. To that end, petitioner's motion is granted and its response is now due to be filed on or before December 10, 2010. The petitioner also stated that it will file an additional 60 day waiver of the statutory decision deadline.

The parties or their legal representatives are reminded and directed to appear at a telephonic status conference with the hearing officer on November 30, 2010, at 10:45 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




