### REQUEST FOR EXTENSION OF TIME TO FILE RECORD

NOW COMES the Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by LISA MADIGAN, Attorney General of the State of Illinois and, pursuant to 35 Ill. Adm. Code 105.116, moves the ILLINOIS POLLUTION CONTROL BOARD ("Board") for an extension of the time to file the record of its determination in this matter.

- 1. Petitioner, Midwestern Regional Medical Center Inc., filed its Petition with the Board on September 28, 2010, seeking a review of certain permit conditions contained within the lifetime operating permit issued by the Illinois EPA on August 18, 2010. The permit authorized the operation of one 1800 horsepower diesel emergency generator at Petitioner's facility located at 2520 Elisha Avenue in Zion, Illinois.
- 2. On October 7, 2010, the Board accepted the Petition for hearing. In addition, the Board ordered the Respondent to file the record of its determination, or request for extension for filing the record, on or before October 28, 2010.
- 3. The undersigned has spoken with Counsel for Petitioner, who has agreed to a 60 day extension of the deadline for filing the record in this matter, or until

December 27, 2010. The undersigned also believes that the parties may be able to reach an agreed resolution of this matter during this 60 day period, making the filing of the record, and full prosecution of this Appeal, unnecessary.

4. The undersigned is aware that the Board must also consider its statutory decision deadline in granting any extension, and *believes* that Petitioner will agree to an extension of this decision deadline. Accordingly, the undersigned suggests that a Hearing Officer be assigned, and that an initial status be scheduled within 7 to 10 days of the date of filing this Request, so that the Board may be advised on Petitioner's willingness to so extend.

WHEREFORE, Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, respectfully requests that the Board extend the deadline for filing the complete record in this matter to December 27, 2010.
