

**HEARING OFFICER ORDER**

On November 4, 2010, the complainant informed the hearing officer that the remaining respondent, Weitz Industrial, LLC., (Weitz) have a apparently settled and that a draft stipulation and proposal for settlement (stipulation) is being circulated for review and for signatures. To that end, and by agreement, Weitz answer or other pleading, is now due to be filed on or before January 6, 2011.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on January 20, 2011, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




