
HEARING OFFICER ORDER

On November 18, 2010, all parties participated in a telephonic status conference with the hearing officer. The parties represented that they have made progress towards a resolution and continue to request that the Board delay its decision concerning the motion to stay the effectiveness of contested permit conditions, filed June 29, 2010. Also by agreement, the record in this matter is now due to be filed on or before February 1, 2011.

The petitioner stated that it will file an additional 60 day waiver of the statutory decision deadline.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on February 3, 2011, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




