

**HEARING OFFICER ORDER**

On November 29, 2010, the parties advised the hearing officer that a draft motion to vacate trade secret determinations has been reviewed. The accepted briefing schedule is as follows. The petitioners must file their motion to vacate on or before December 17, 2010. Respondent's response is due to be filed on or before January 14, 2011. Petitioners reply is due to be filed on or before January 28, 2011. The petitioners will file an additional six month waiver of the statutory decision deadline.

The parties or their legal representatives are directed to participate in a telephonic status conference on February 24, 2011, at 1:00 p.m. The status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


