

HEARING OFFICER ORDER

On November 30, 2010, the parties informed the hearing officer that a permit in a related permit appeal has been issued and will serve as a model for this appeal. The parties also stated that there appears to be one issue outstanding that the parties are discussing. The petitioners stated that they will file an additional 60-day waiver of the statutory decision deadline. The respondent's answer and record due date will be discussed at the next status conference.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 3, 2011, at 10:30 a.m. The telephonic status conference must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




