HEARING OFFICER ORDER

On December 7, 2010, the following parties participated in a telephone status conference with the hearing officer: Complainant; A.E. Staley Manufacturing Co., Bell Sports, Inc., Borden Chemical Co., Borg Warner, Inc., Caterpillar, Inc., Climate Control, Inc., Combe Laboratories, Inc., Trinity Rail Group, Inc., and Triple S Refining. The following respondents did not appear: Waste Hauling Landfill, Inc., Jerry Camfield, Aramark Uniform Services, Inc., Bridgestone/Firestone, Inc., General Electric Railcar Services Corporation, and P & H Manufacturing, Inc.

On December 2, 2010, the Board accepted the second amended complaint for hearing. The parties agree that the deadline for all respondents to answer the complaint is stayed. Several parties are in various stages of settlement, while settlement may be unlikely for a few parties. A deadline for answering the second amended complaint may be reinstated at the next status call for parties not engaged in settlement negotiations.

The stay of proceedings against respondent Triple S Refining Corporation remains in effect until January 16, 2011.
