PETITION FOR REVIEW OF AGENCY LUST DECISION

NOW COMES Petitioner, KB Sullivan, Inc., pursuant to Sections 40 and 57.8(i) of the Illinois Environmental Protection Act, 415 ILCS 5/40 & 5/57.8(i), and hereby appeals the LUST decision issued on December 9, 2010, by Respondent Illinois Environmental Protection Agency ("Agency"), in which the Agency rejected an application for payment for costs previously approved, stating further as follows:

- The subject facility is located at 111 West Jackson Street, Sullivan, Moultrie County, Illinois.
- 2. The subject facility has been operated as a service station for many years, containing several underground storage tanks, from which a release was reported from one or more on January 17, 1990 and assigned IEMA Incident Number 900146.
- 3. On July 29, 2004, during removal of tanks, another release was reported and assigned IEMA Incident Number 20040969. By reason and belief, the Agency considers this to be a re-reporting of the previous incident.
- 4. Subsequently, the owner/operator of the underground storage tanks applied for and received eligibility determinations for the clean-up of both incidents and since all of the tanks were registered, a deductible of \$10,000 was assigned.

- 5. On February 15, 2010, KB Sullivan, Inc. notified the Agency in writing that it had acquired an ownership interest in the subject property and was electing to proceed as owner in completing site investigation and corrective action with the goal of obtaining a No Further Remediation Letter.
 - 6. On March 4, 2010, the Agency accepted the election to proceed as owner.
- 7. On September 7, 2010, KB Sullivan, Inc. submitted an application for payment for site investigation activities performed at the site, seeking \$22,232.14 for site investigation activities performed pursuant to budgets approved by the Agency in 2006.
- 8. On December 9, 2010, the Agency denied payment in a letter attached hereto as Exhibit A, and which was received December 10, 2010, which is less than thirty-five days from the date of this filing.
- 9. The Agency erroneously states that KB Sullivan does not meet the definition of Owner in Section 57.2 or 22.18(e)(1)(B) of the Act. The Act specifically provides for ownership by election as was done by KB Sullivan:

the term "owner" shall also mean any person who has submitted to the Agency a written election to proceed under this Title and has acquired an ownership interest in a site on which one or more registered tanks have been removed, but on which corrective action has not yet resulted in the issuance of a "no further remediation letter" by the Agency pursuant to this Title.

(415 ILCS 5/57.2)

10. The Agency erroneously states that KB Sullivan failed to comply with the Agency's rules requiring all payment applications to include a copy of the OSFM eligibility and

deductibility determination. See 35 Ill. Admin. Code § 734.605(b)(3). KB Sullivan in

performing the site investigation work initiated by the prior owner, submitted the OSFM

determination received by the prior owner after tanks were removed. There is nothing expressly

in the Agency's rules that require additional OSFM determinations to be made by each future

owner, particularly since OSFM determines the eligibility of tanks, not owners.

WHEREFORE, Petitioner, KB SULLIVAN, INC., prays that: (a) the Agency produce the

Record; (b) a hearing be held; (c) the Board find the Agency erred in its decisions, (d) the Board

direct the Agency to approve the payment in full, (e) the Board award payment of attorney's fees;

and (f) the Board grant the Petitioner such other and further relief as it deems meet and just.



In addition, pursuant to 35 IAC Section 734.605(b)(3) a complete application for payment must contain a copy of the OSFM eligibility and deductibility determination. An eligibility and deductibility determination for incident number 900146 was issued to Convenience and Petroleum Marketing, LLC not KB Sullivan for which payment has been requested.

In addition, KB Sullivan does not meet the definition of Owner or Operator in Section 57.2 or 22.18(e)(1)(B) of the Act therefore, all costs incurred regarding this incident are not eligible for reimbursement from the Fund to KB Sullivan.



Appeal Rights

An underground storage tank owner or operator may appeal this final decision to the Illinois Pollution Control Board pursuant to Sections 40 and 57.7(c)(4) of the Act by filing a petition for a hearing within 35 days after the date of issuance of the final decision. However, the 35-day period may be extended for a period of time not to exceed 90 days by written notice from the owner or operator and the Illinois EPA within the initial 35-day appeal period. If the owner or operator wishes to receive a 90-day extension, a written request that includes a statement of the date the final decision was received, along with a copy of this decision, must be sent to the Illinois EPA as soon as possible.
