## ORDER OF THE BOARD (by G. T. Girard):

On January 13, 2011, KB Sullivan, Inc. (Sullivan) timely filed a petition asking the Board to review a December 9, 2010 determination of the Illinois Environmental Protection Agency (Agency). *See* 415 ILCS 5/40(a)(1) (2008); 35 Ill. Adm. Code 101.300(b), 105.402, 105.404. The Agency's determination concerns Sullivan's leaking underground storage tank (UST) site at 111 West Jackson Street in Sullivan, Moultrie County. For reasons below, the Board accepts Sullivan's petition for hearing.

Under the Environmental Protection Act (Act) (415 ILCS 5 (2008)), the Agency decides whether to approve proposed cleanup plans and budgets for leaking UST sites, as well as requests for cleanup cost reimbursement from the State's UST Fund, which consists of UST fees and motor fuel taxes. If the Agency disapproves or modifies a submittal, the UST owner or operator may appeal the decision to the Board. *See* 415 ILCS 5/40(a)(1), 57-57.17 (2008); 35 Ill. Adm. Code 105.Subpart D. In this case, the Agency denied Sullivan's request for reimbursement from the UST Fund for the Moultrie County UST site. Sullivan appeals on the grounds that it is the UST "owner" by election and that it provided the Agency with the Office of the State Fire Marshal's "eligibility and deductibility" determination received by the prior owner. Sullivan's petition meets the content requirements of 35 Ill. Adm. Code 105.408.

The Board accepts the petition for hearing. Sullivan has the burden of proof. *See* 35 Ill. Adm. Code 105.112(a). Hearings will be based exclusively on the record before the Agency at the time the Agency issued its determination. *See* 35 Ill. Adm. Code 105.412. Accordingly, though the Board hearing affords petitioner the opportunity to challenge the Agency's reasons for its decision, information developed after the Agency's decision typically is not admitted at hearing or considered by the Board. *See* Alton Packaging Corp. v. PCB, 162 Ill. App. 3d 731, 738, 516 N.E.2d 275, 280 (5th Dist. 1987); Community Landfill Co. & City of Morris v. IEPA, PCB 01-170 (Dec. 6, 2001), *aff'd sub nom.* Community Landfill Co. & City of Morris v. PCB & IEPA, 331 Ill. App. 3d 1056, 772 N.E.2d 231 (3rd Dist. 2002).

Hearings will be scheduled and completed in a timely manner, consistent with the decision deadline (see 415 ILCS 5/40(a)(2) (2008)), which only Sullivan may extend by waiver

(see 35 III. Adm. Code 101.308). If the Board fails to take final action by the decision deadline, Sullivan may deem its request granted. See 415 ILCS 5/40(a)(2) (2008). Currently, the decision deadline is May 13, 2011, which is the 120th day after the date on which the Board received the petition, January 13, 2011. See 35 III. Adm. Code 105.114. The Board meeting immediately before the decision deadline is scheduled for May 5, 2011.

Unless the Board or the hearing officer orders otherwise, the Agency must file the entire record of its determination by February 14, 2011, which is the first business day following the 30th day after the date on which the Board received Sullivan's petition. *See* 35 Ill. Adm. Code 101.300(a), 105.410(a). If the Agency wishes to seek additional time to file the record, it must file a request for extension before the date on which the record is due to be filed. *See* 35 Ill. Adm. Code 105.116. The record must comply with the content requirements of 35 Ill. Adm. Code 105.410(b).
