HEARING OFFICER ORDER


On February 3, 2011, all parties participated in a telephonic status conference with the hearing officer. The respondent stated that it has recently filed the record in the above-captioned matter. The respondent also stated that it is no longer in agreement regarding the parties request to delay the Board's ruling on petitioner's motion to stay, filed June 29, 2011.

By agreement, the petitioner must file its reply to respondent's response in opposition to motion to stay on or before February 17, 2011.

The petitioner stated that it will file an additional 60 day waiver of the statutory decision deadline.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on April 7, 2011, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


