

HEARING OFFICER ORDER

On February 7, 2011, the petitioner informed the hearing officer that the parties continue to be involved with internal discussions regarding how to proceed and that the parties, including technical personnel, have met since the last telephonic status conference. IT IS SO ORDERED.




