3. The first Hearing Officer Status is scheduled for February 28, 2011. Respondent

REQUEST FOR EXTENSION OF TIME TO FILE RECORD

Now comes Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), by LISA MADIGAN, Attorney General of the State of Illinois, and respectfully requests a thirty (30) day extension of time to file the record of Illinois EPA's decision on the permit at issue in this case. In support of its request, Respondent states, as follows.

 Petitioner KCBX Terminals Company ("KCBX") filed this permit appeal with The Board on February 1, 2011. Pursuant to Section 105.116 of the Board's Procedural Rules, unless an extension is granted, Illinois EPA is to file the record of its permit decision by March 4, 2011.

2. The instant case is the third permit appeal filed by Petitioner since June, 2008. By agreement, Illinois EPA obtained an extension of filing the record in the *second* appeal (PCB 10-110), and filed the record in that case on February 1, 2011, the same day this *third* permit appeal was filed by KCBX.

3. In this case, KCBX appeals certain conditions of the Site's renewed FESOP permit, which covers all pertinent Site activities. Assembly of the record in this appeal will require significant time and resources. However, the undersigned is scheduled to travel to Illinois

EPA's Springfield, Illinois offices on March 2-3, 2011 on other matters, and will also be able to assist in preparation of the record filing at that time.

4. Respondent requests that the Board grant an additional thirty (30) days for filing of Illinois EPA's record of decision, until April 4, 2011.
