**HEARING OFFICER ORDER**

On March 15, 2011, the following parties participated in a telephone status conference with the hearing officer: Complainant, A.E. Staley Manufacturing Co., Aramark Uniform Services; Bell Sports, Inc., Borden Chemical Co., Borg Warner, Inc., Bridgestone/Firestone Inc., Caterpillar, Inc., Combe Laboratories, Inc., Trinity Rail Group, Inc., and Triple S Refining Corporation. The following respondents did not appear: Waste Hauling Landfill, Inc., Jerry Camfield, Climate Control, Inc., General Electric Railcar Services Corporation, and P & H Manufacturing, Inc.

Proposed settlement agreements have been filed for respondents Aramark, Bell Sports, Caterpillar, General Electric Railcar, and P & H Manufacturing. Settlement discussions continue with the remaining respondents other than Waste Hauling Landfill and Jerry Camfield. A global settlement agreement has been approved for respondent Triple S Refining, and complainant will soon be filing a motion to voluntarily dismiss this respondent. The deadline for all respondents to answer the complaint remains stayed.
