MOTION TO WAIVE THE REQUIREMENT TO FILE COPIES OF CERTAIN DOCUMENTS COMPRISING THE RECORD

Respondent Village Board of the Village of Davis Junction, Illinois ("Village"), by its attorneys, moves the Hearing Officer for an order granting a waiver from the requirement to file three (3) copies of certain documents comprising the record with the Illinois Pollution Control Board ("Board"). In support of its Motion, the Village states as follows:

- 1. The Order of the Board dated June 6, 1996, requires the Clerk of the Village of Davis Junction ("Village Clerk") to prepare and file the record on appeal. Specifically, the Village Clerk is required to file the original and seven (7) copies of the transcript of the local hearing and the original and three (3) copies of any other documents in the record by June 27, 1996.
- 2. The documents comprising the record include, but are not limited to, full-scale engineering drawings, site plans, landscaping plans, maps, samples of landfill construction materials, slides, diskettes, and oversized foam boards. A list of these documents is contained in Exhibit A, attached hereto and made a part hereof.
- 3. The cost of making three (3) copies of these documents would be inordinately expensive without commensurate benefit to the Board or Hearing Officer. Many of the documents

are merely blown-up versions of drawings already contained in the siting application, of which the Village Clerk intends to file three (3) copies. In addition, the drawings, site plans, landscaping plans, maps and foam boards are difficult to copy and use because of their sheer size and would not be legible once reduced. Further, it is not possible for copies of the sample landfill construction materials to be made.

- 4. The originals of these documents will be made available at the public hearing scheduled for July 16, 1996, and then filed with the Board. The documents will, therefore, be available for review by the Board members, the Hearing Officer and the general public.
- 5. The Village intends to file three (3) copies of all other documents comprising the record.

WHEREFORE, the Village Board of the Village of Davis Junction respectfully requests that the Hearing Officer waive the requirement to file (3) copies of certain documents comprising the record described in Exhibit A attached hereto.
