MOTION TO FILE REDUCED NUMBER OF ADMINISTRATIVE RECORD COPIES

The ILLINOIS ENVIRONMENTAL PROTECTION AGENCY (Illinois EPA), by one of its attorneys. William D. Ingersoll, Special Assistant Attorney General, and pursuant to 35 Ill. Adm. Code 101.500 and 101.302(h), hereby requests that the Pollution Control Board (Board) allow the Illinois EPA to file one original, one duplicate copy and one electronic copy (pdf) of the Administrative Record in this matter.
