PETITIONER'S MOTION TO SUPPLEMENT THE RECORD

NOW COMES Petitioner, KCBX TERMINALS COMPANY ("KCBX"), a North Dakota corporation, by and through its attorneys, HODGE DWYER & DRIVER ("HD&D"), and hereby moves to supplement the record before the Illinois Pollution Control Board ("Board") with certain documents the Illinois Environmental Protection Agency ("Illinois EPA") relied upon in making its determination regarding KCBX's application for the renewal of its Federally Enforceable State Operating Permit ("Renewed FESOP") for KCBX's bulk solids materials terminal located in Chicago, Illinois ("Facility").
