

HEARING OFFICER ORDER

On May 18, 2011, all parties participated in a telephonic status conference with the hearing officer. The parties' attorneys stated that they continue to try and arrange a meeting with the Illinois Environmental Protection Agency in an attempt to resolve this matter. The petitioner stated that it will file an additional 120 day waiver of the statutory decision deadline.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on September 15, 2011, at 1:30 p.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




