NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, UNITED STATES STEEL CORPORATION ("Petitioner"), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board ("Board") in this proceeding until December 15, 2011. In support of this Notice, Petitioner states as follows:

1. On October 7, 2009, Petitioner filed a Petition for Review ("Petition") of the Clean Air Act Permit Program ("CAAPP") permit (No. 96030056) ("Permit") issued on September 3, 2009, by the Illinois Environmental Protection Agency ("Illinois EPA") for Petitioner's integrated steel mill plant located in Granite City, Illinois.

2. On October 15, 2009, the Board accepted Petitioner's Petition for hearing. Board Order, *United States Steel Corporation v. Illinois EPA*, PCB No. 10-23 (Ill.Pol.Control.Bd. Oct. 15, 2009). On December 3, 2009, the Board granted American

Bottom Conservancy's Motion to Intervene. Board Order, *United States Steel Corporation v. Illinois EPA*, PCB No. 10-23 (Ill.Pol.Control.Bd. Dec. 3, 2009).

3. On May 2, 2011, Illinois EPA issued a final Revised CAAPP Permit. Pursuant to Section 40.2 of the Illinois Environmental Protection Act, the permittee has 35 days after final permit action to petition the Board for hearing to contest Illinois EPA's decision. 415 ILCS 5/40.2(a). Since the appeal period has yet to lapse, Petitioner has requested that the status conference be postponed until at least 30 days after the close of the appeal period.

4. The current statutory decision deadline for this matter is September 15, 2011.

5. In order to postpone the status conference scheduled for June 6, 2011, for at least 30 days after the close of the appeal period, Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until December 15, 2011.

WHEREFORE, Petitioner, UNITED STATES STEEL CORPORATION, prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline until December 15, 2011 for final action on Petitioner's Petition for Review.
