HEARING OFFICER ORDER


On May 18, 2011, the parties submitted a proposed discovery schedule. The discovery schedule is accepted to the extent as follows. The administrative record in the above-captioned appeal is now due to be filed on or before June 13, 2011. All written discovery must be served on or before July 13, 2011. All responses to the written discovery must be served on or before August 31, 2011. The parties agreed to a limit of 30 interrogatories and 30 requests to admit.

The petitioner also stated that it would file an additional waiver of the statutory decision deadline to and including March 2, 2012.

In light of the above agreed to discovery schedule, the telephonic status conference previously scheduled for June 21, 2011, has been cancelled and is rescheduled to the date and time noted below.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 22, 2011, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


