

**HEARING OFFICER ORDER**

On June 9, 2011, all parties participated in a telephonic status conference with the hearing officer. The parties stated that the Illinois Environmental Protection Agency (Agency) is still reviewing all of the respondent's financial information for settlement purposes. It is noted that the original financial documents were forwarded to the Agency in October, 2010, with requested additional financial information forwarded in February 2011. Respondent expressed its concern over the timeliness of the review, and wishes this matter to reach a resolve in the near future.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on August 25, 2011, at 10:00 a.m. The telephonic status conference must be initiated by the complainant, but each party nonetheless is responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




