
HEARING OFFICER ORDER

A telephonic status conference was held on June 9, 2011. Complainant's counsel informed the hearing officer earlier that she had a scheduling conflict and could not appear and to proceed without her. Complainant's attorney orally requested her fifth extension of time to respond to interrogatories.


