MOTION TO DISMISS RESPONDENT RAYMOND A. HARRIS

NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Assistant Counsel Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:

(1) On June 2, 2011, Illinois EPA issued an Administrative Citation to Respondents DENNIS HECK, and RAYMOND A. & DEANNA HARRIS, based on an inspection conducted on March 29, 2011.

(2) On May 12, 2011, Illinois EPA filed proof of apparent service on RespondentsRAYMOND A. & DEANNA HARRIS by certified mail.

(3) On or about May 25, 2011, Assistant Counsel Michelle M. Ryan spoke to Respondent DEANNA HARRIS on the telephone. DEANNA HARRIS informed Ms. Ryan that she and RAYMOND HARRIS were divorced and that RAYMOND HARRIS did not and had never resided at the address at which Illinois EPA attempted to serve him.


