ILLINOIS EPA'S RESPONSE TO MIDWEST GENERATION'S MOTION FOR TEMPORARY SUSPENSION OF SUBDOCKET D HEARINGS

The Illinois Environmental Protection Agency ("Illinois EPA") hereby submits its response to Midwest Generation's Motion for Temporary Suspension of Subdocket D hearings. Illinois EPA states as follows:

- 1. On June 14, 2011, Midwest Generation filed its Motion for a Temporary Suspension of Subdocket D with the Illinois Pollution Control Board ("Board").
- 2. Midwest Generation is asking the Board to temporarily suspend hearings in Subdocket D until the Board proceeds to First Notice in Subdocket C. (Motion P. 2).
- 3. The Illinois EPA does not object to Midwest Generation's request to wait until a First Notice Opinion and Order is issued in Subdocket C before proceeding with hearings in Subdocket D. It is reasonable for the parties to want to see what aquatic life uses are being proposed by the Board before presenting a case in Subdocket D with respect to water quality standards to protect those aquatic life uses.
- 4. Midwest Generation further submits that the recent Subdocket A events concerning the filing of both USEPA's May 11, 20011 Determination Letter (See Public Comment #584) and the Illinois EPA May 16th, 2011 Motion to Stay have resulted in significant changes to the proposed recreational uses in the Board's Proposed Second

Notice in Subdocket A and there is a threat this could happen again in regard to Subdocket D based on a January 29, 2010 letter by the USEPA. (See Public Comment #286). Therefore, to prevent a similar outcome in Subdockets C and D, Midwest Generation asks that Illinois EPA be required to file a response to the January 2010 USEPA letter before hearings in Subdocket D are scheduled. (Motion P. 8).

5. Having Illinois EPA file a response to the January 2010 letter before scheduling hearings in Subdocket D would not be beneficial to the Board and the participants at this time and would cause unnecessary delay. Illinois EPA is continuing to work on these issues internally and with USEPA to discuss the issues raised in the January 2010 letter. Illinois EPA is willing to provide the Board and participants a status report with respect to how these issues are progressing internally and with USEPA. Furthermore, Illinois EPA strongly opposes holding off hearings in Subdocket D while working on these issues because there would be a benefit in seeing the information that will be presented from the various parties during the hearing process. The information presented during the hearings could potentially help Illinois EPA resolve issues raised by USEPA in the January 2010 letter.

WHEREFORE, the Illinois EPA respectfully agrees with Midwest Generation that Subdocket D hearings should not move forward until a First Notice Opinion and Order is issued Subdocket C. Illinois EPA further requests that Midwest Generation's request that Illinois EPA file a response to the USEPA January 2010 letter be denied.
