NOW COMES Respondent, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY, ("Illinois EPA" or "Agency"), by and through Lisa Madigan, Attorney General of the State of Illinois, and pursuant to 35 Ill. Adm. Code 101.502, hereby respectfully moves the Hearing Officer to extend the date for filing the Administrative Record in this consolidated permit appeal. 4. Petitioner has been consulted and does not object to the granting of this motion.


