**HEARING OFFICER ORDER**

The scheduled telephonic status conferences on August 15, 2011, and August 16, 2011, were continued to August 17, 2011, at 11:00 a.m. Discussions centered on the filing of petitioner's additional waiver of the statutory decision deadline, to an including December 1, 2011.


To that end, a post- hearing briefing schedule was discussed and agreed to. Petitioner's opening brief is due to be filed on or before October 7, 2011. The respondent's responsive brief is due to be filed on or before October 17, 2011. Petitioner's reply brief is due to be filed on or before October 21, 2011. The mailbox rule does not apply to any of the post-hearing briefs, and all electronic or approved telefax filings must be received by the Clerk's office no later than 4:30 p.m. of the due date. The record in the above-captioned matter is closed on October 21, 2011.

Discovery is closed on August 24, 2011. All pre-hearing motions, including motions *in limine*, must be filed on or before September 2, 2011. All responses to the pre-hearing motions are due to be filed on or before September 7, 2011. The mailbox rule does not apply to the above pleadings, and all electronic or approved telefax filings must be received by the Clerk's office no later than 4:30 p.m. of the due date.

The parties are reminded that the hearing scheduled for September 19, 2011, commences at 10:00 a.m. It is noted that the parties agreed that the hearing will be completed by or before 4:00 p.m. on that day.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on August 29, 2011, at 11:00 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


