RECOMMENDATION

NOW COMES the ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("Illinois EPA"), through its attorneys, and pursuant to 35 Ill. Adm. Code 125.204 of the ILLINOIS POLLUTION CONTROL BOARD'S ("Board") procedural regulations, files the Illinois EPA's Recommendation in the above-referenced request for tax certification of pollution control facilities. The Illinois EPA recommends issuance of a tax certification covering the subject matter of the request. In support thereof, the Illinois EPA states as follows:

- 1. On or about October 14, 2010, the Illinois EPA received an application and supporting information from WRB REFINING, LLC, ("WRB Refining") concerning the proposed tax certification of certain air emission sources and/or equipment located at its Wood River petroleum refinery in Madison County, Illinois. A copy of the application is attached hereto. [Exhibit A].
 - 2. The applicant's principal business address is as follows:

WRB Refining LLC 404 Phillips Building Bartlesville, Oklahoma 74004

3. The facility address is as follows:

WRB Refining LLC 900 South Central Avenue P.O. Box 76 Roxana, Illinois 62084

- 4. The subject matter of this request consists of the a fuel-fired furnace, designated as Boiler No. 17, that combusts refinery fuel gas to generate high pressure steam for use in the refinery's operations. Due to both the presence of nitrous oxides ("NOx") in the furnace flue gas and the unique configuration of the furnace, the refinery selected Boiler No. 17 to implement controls that reduce NOx formation through Flue Gas Recirculation ("FGR"). As explained in the application, this process acts to reduce the flame temperature by returning some component of the flue gas streams to the burners. The recirculated gas is introduced to incoming combustion air, absorbing heat from the burners and cooling the flame temperature. The adoption of FGR required the installation of "ducting, supports and access platforms," as well as modifications to the existing boiler controls and operations system. The impetus of the project stemmed from the recent adoption of NOx regulations in 35 III. Adm. Code Part 217.
- Section 11-10 of the Property Tax Code, 35 ILCS 200/11-10 (2002), defines
 "pollution control facilities" as:
 - "any system, method, construction, device or appliance appurtenant thereto, or any portion of any building or equipment, that is designed, constructed, installed or operated for the primary purpose of: (a) eliminating, preventing, or reducing air or water pollution... or (b) treating, pretreating, modifying or disposing of any potential solid, liquid, gaseous pollutant which if released without treatment, pretreatment, modification or disposal might be liarniful, detrimental or offensive to human, plant or animal life, or to property."
- Pollution control facilities are entitled to preferential tax treatment, as provided by
 ILCS 200/11-5 (2002).
- 7. Based on information in the application and the underlying purpose of the Boiler No. 17 NOx Reduction project to prevent, eliminate or reduce air pollution, it is the Illinois EPA's engineering judgment that the various systems, constructions, devices and/or buildings or equipment from the project relating to air pollution control may be considered as "pollution

control facilities" in accordance with the statutory definition and consistent with the Board's regulations at 35 Ill. Adm. Code 125.200. [Exhibit B].

8. Because the substantive components of the application for the Boiler No. 17 NOx Reduction project satisfies the aforementioned criteria, the Illinois EPA recommends that the Board issue the applicant's requested tax certification.

Section D - Pollution Control Facility Description


This project was implemented for the sole purpose of reducing Boiler #17 NOx emissions.

Fuel fired furnaces produce nitrogen oxides (NOx) which is an air pollutant released to the atmosphere in the furnace flue gas. NOx is formed when nitrogen and oxygen in the combustion air combine with one another at the high temperatures in a flame. One method to reduce NOx formation is to lower the flame temperature by recirculating some flue gas back to the burners. The recirculated flue gas is mixed with the incoming combustion air and acts as a diluent, absorbing some of the heat released at the burners, and thus cooling the flame temperature and limiting the formation of NOx. This method of reducing NOx formation is called Flue Gas Recirculation or FGR.

Boiler #17 burns refinery fuel gas to produce high pressure steam for use in the refinery. The combustion firebox of Boiler #17 operates above atmospheric pressure and thus a forced draft fan is required to supply the combustion air. This configuration makes Boiler #17 a good application for the FGR method of NOx reduction.

This project installed the flue gas ducting, supports, and access platforms necessary to recirculate Boiler #17 flue gas back to the boiler's combustion air inlet. The project also modified the Boiler #17 controls and burner management system as necessary to implement FGR.

This project was installed to comply with new ILEPA regulations on NOx emissions. This project lowers the NOx emissions from Boiler 17 to 0.08 lbs NOx/MMBTU from 0.20 lbs NOx/MMBTU. The Wood River Refinery receives no financial benefit from this project.

This Agency received a request on October 14, 2010 from WRB Refining, LLC. for an Illinois EPA recommendation regarding tax certification of air pollution control facilities pursuant to 35 Ill. Adm. Code 125.204. I offer the following recommendation.

The air pollution control facilities in this request include the following:

Boiler 17 NO_x Reduction Project which reduces NO_x emissions by lowering the flame temperature by recirculating flue gas back to the burners. Because the primary purpose of this system is to reduce or eliminate air pollution, it is certified as a pollution control facility.

This facility is located at 900 South Central Avenue, Roxana, Illinois The property identification number is 19-1-08-35-00-000-001

Based on the information included in this submittal, it is my engineering Judgement that the proposed facility may be considered "Pollution Control Facilities" under 35 IAC 125.200(a), with the primary purpose of eliminating, preventing, or reducing air pollution, or as otherwise provided in this section, and therefore eligible for tax certification from the Illinois Pollution Control Board.
